Sir,

With reference to no. 2, 3, 4 and 5, the final notification for reservation of seats was to be issued in 12 Corporations and reservation of draw was to be made in 9 Corporations on 05/08/2022. Similarly, final


notification for reservation of seats was to be issued in 2 Corporations on 12/08/2022.

With reference to no. 1, the State has promulgated Ordinance no. VII of 2022, dated 04/08/2022; making Amendment to the Mumbai Municipal Corporation Act, 1888 and Maharashtra Municipal Corporation Act, 1949 and thereby has changed the total number of seats of the Municipal Corporations. It has also annulled all the process of delimitation and reservation done so far by State Election Commission and has provided that such process shall be started afresh.

In view of the Ordinance no VII of 2022, dated 04/08/2022 and provisions made thereunder, you are directed to stop the above stated process as on 04/08/2022 and wait for issuing the final notification and draw of lots for reservations as the case may till further orders.
